Monday 8/19/13 to Friday 8/23/13:

Incidents:

- On Tuesday 8/20/13 at 11:00pm, complainant was confronted by a male with a handgun in the hallway of an apartment building in the 1200 block of Buttonwood St.; the male forced his way into complainant's apartment and took an iPhone and a handbag; offender was described as Hispanic, 30-35 yrs. old, 6', wearing a white hoodie, brown fishing hat and blue jeans.
